Payment Policy & Terms and Conditions (Spring & Summer 2022)

Payment Policies – My Stage

Spring 2022 (Spring Tuition Only):

My Stage is intended as a year-long production class that sells out and relies on every student once it is cast. Once you register, it is with the intention of participating for the year class. Billing for the Spring 2022 is scheduled on the following dates:

Non-Refundable deposit - \$150 billed upon registration for Spring MyStage Class

Spring 2022- K-2nd Grade

Installment 1 - \$159.00 is debited on Jan 10, 2022

Installment 2 - \$159.00 is debited on March 1, 2022

Installment 3 - \$159.00 is debited on April 1, 2022

Installment 4 - \$159.00 is debited on May 1, 2022

Spring 2022 - 3rd-5th Grade

Installment 1 - \$189.00 is debited on Jan 10, 2022

Installment 2 - \$189.00 is debited on March 1, 2022

Installment 3 - \$189.00 is debited on April 1, 2022

Installment 4 - \$189.00 is debited on May 1, 2022

Tuition includes all tech/show snacks and show recording.

- **MyStage Dropping Class Policy:** In the event that you drop prior to casting but after the first class has begun, no refunds will be given, however, you will not be expected to pay for the remainder of the tuition. Should you drop after casting, you agree to pay for the remaining tuition as we are unable to backfill your child's specific role. In addition, those that drop after casting simply because they didn't get the part, they wanted will not be allowed to do the following season. Entitlement is not a quality we encourage or nurture at TADA Stages. Learning to make lemonade from lemons is a valuable life skill that enables growth in self-confidence and perseverance. Plus every child gets glad the same street they got mad on and they never regret finishing the show.

Payment Policies - Classes

2022 Spring Tuition Training Classes: First month's tuition plus a one-time registration fee of \$15 is debited upon registration for class. Tuition must be paid by an automatic form of payment either by a credit card or ACH debit from a bank account. Thereafter, tuition will be debited in advance in 4 class blocks. There is a 2-month minimum charge for all classes. One month's notice (30 days) is required to discontinue any class. Withdrawals must be done via email to: evie@tadastages.com. Unused tuition may be applied to other classes in the same season only (2022 Spring season). Two makeups are allowed in any age appropriate class during each season. Makeups are not transferrable to future seasons. Must call to schedule makeup. Absolutely NO REFUNDS.

Payment Policies - Summer Camps

2022 Summer camps will be charged in total upon registration. New students will also pay a one-time registration fee of \$15.00. After summer camp begins, no refunds will be issued for any reason.

Summer Camp Cancellation Policy: If camper withdraws:

Before May 1, 2022 -- Camper can use 50% of the fee paid as credit for another 2022 camp. TADA Stages retains the remaining 50%.

After May 1, 2022 -- TADA retains 100% of the value of the camp and NO REFUNDS and NO CREDIT is given for future TADA or POPs camps, classes or productions. NO EXCEPTIONS.

Publicity and Advertising

TADA Stages retain the right to use for publicity and advertising purposes, any photographs, video tapes and film or audio recordings taken at rehearsals or at the theater.

Assumption of Risk

Your child(ren) have no physical impairment that would be affected by my child(ren)'s participation in any TADA Stages programming and parents assume the risk of any injury or illness that may be incurred by your child(ren) as a result of such participation.

Release of Liability

Parents hereby waive and release Puttin' on Productions Corp, TADA Stages LLC, Leahy Associates, Dolphin Partners, Julia and Mark Mirkovich and their respective staff, owners, employees, directors, representatives and volunteers from any and all liability for injuries or illnesses incurred while at rehearsals at Tada Stages, Hermosa Beach Community Center or during performances at Hermosa Beach Playhouse or another venue.

Medical Emergencies

Parents hereby authorize representatives of Puttin' on Productions and TADA Stages (such representatives to be employees, directors, or identified volunteers) to act on your behalf with their best judgement in any emergency requiring medical attention.

I have read and understand this Payment Policy and Terms and Conditions Agreement. I acknowledge that this document is intended to be and is a binding agreement that affects my child(ren) and my rights and my ability to hold others responsible/liable for any damages, injuries or claims that I may otherwise have. I am voluntarily signing this document on behalf of my child(ren) and myself and have done so without duress or undue influence. I further understand that by signing it, I am releasing certain legal rights that I might otherwise have.
